Insig Life also was privatized 100 % by Eurosig in 2016. Insig Life now operates separated from Insig, as Life insurance Company.

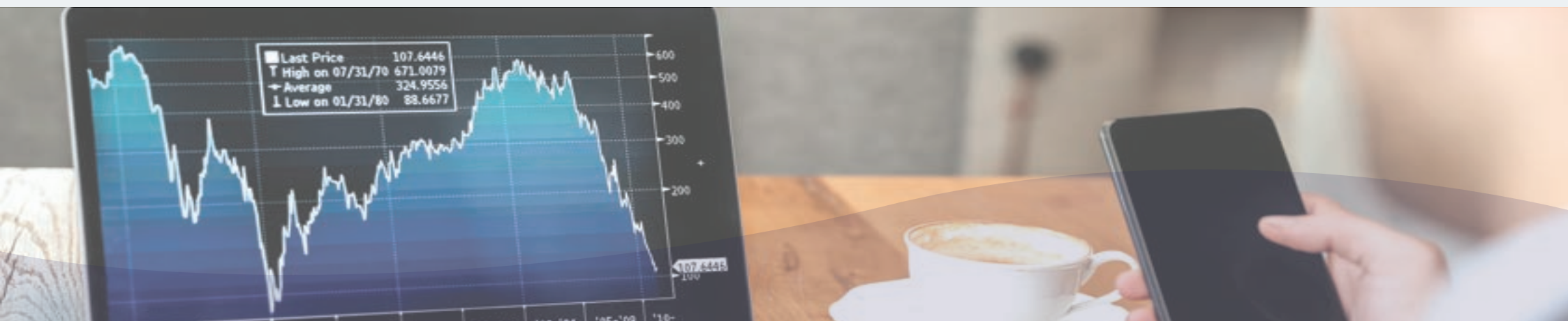
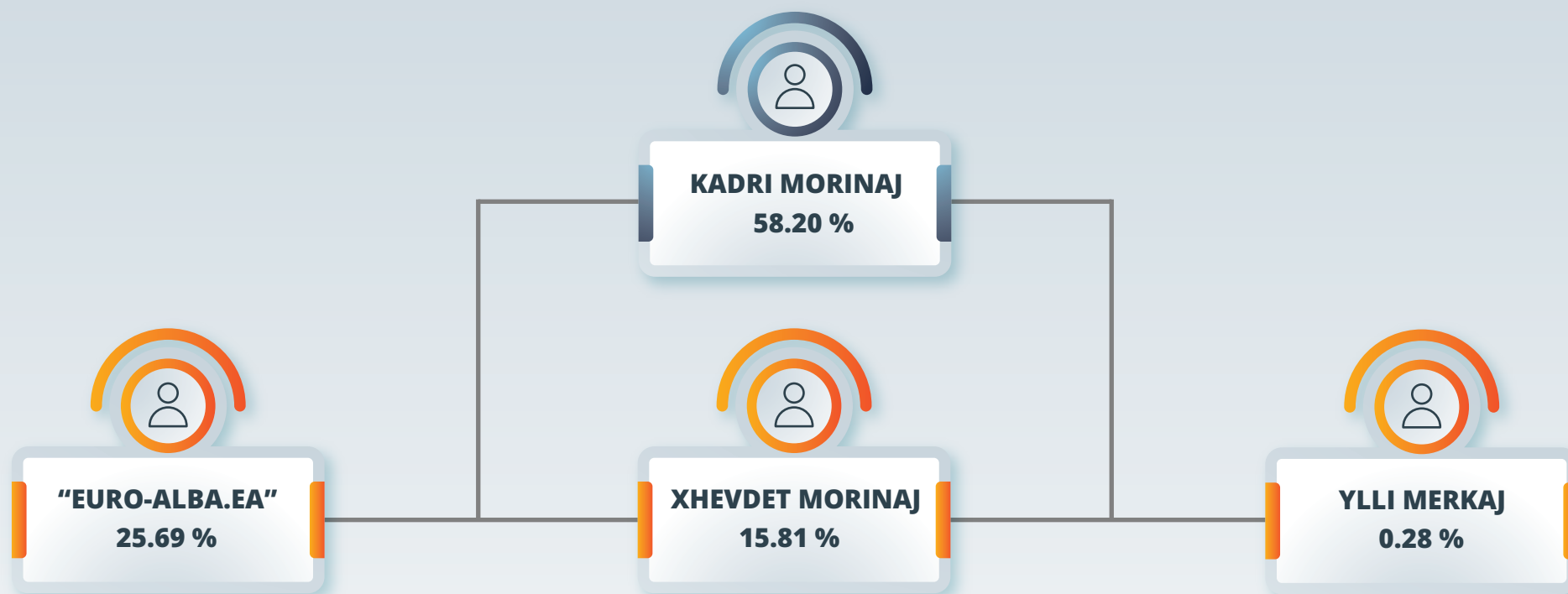


Eurosig already owns the largest share in the United Bank of Albania full 84.8% of the share quotas and investment. UBA Bank was established in 1993.

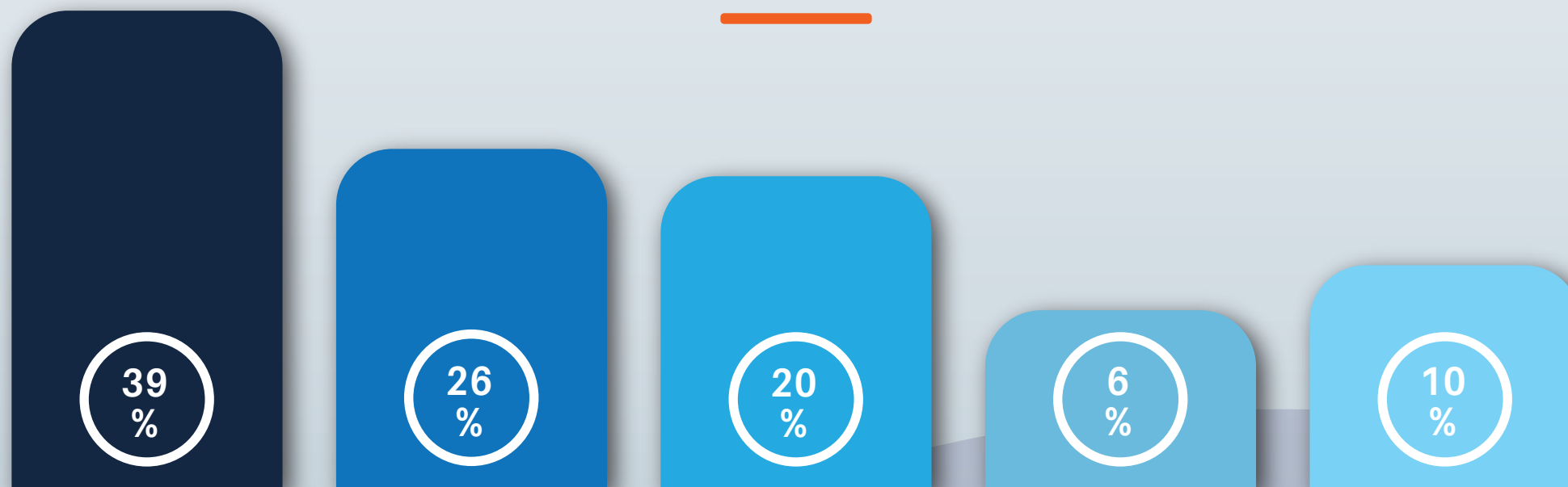

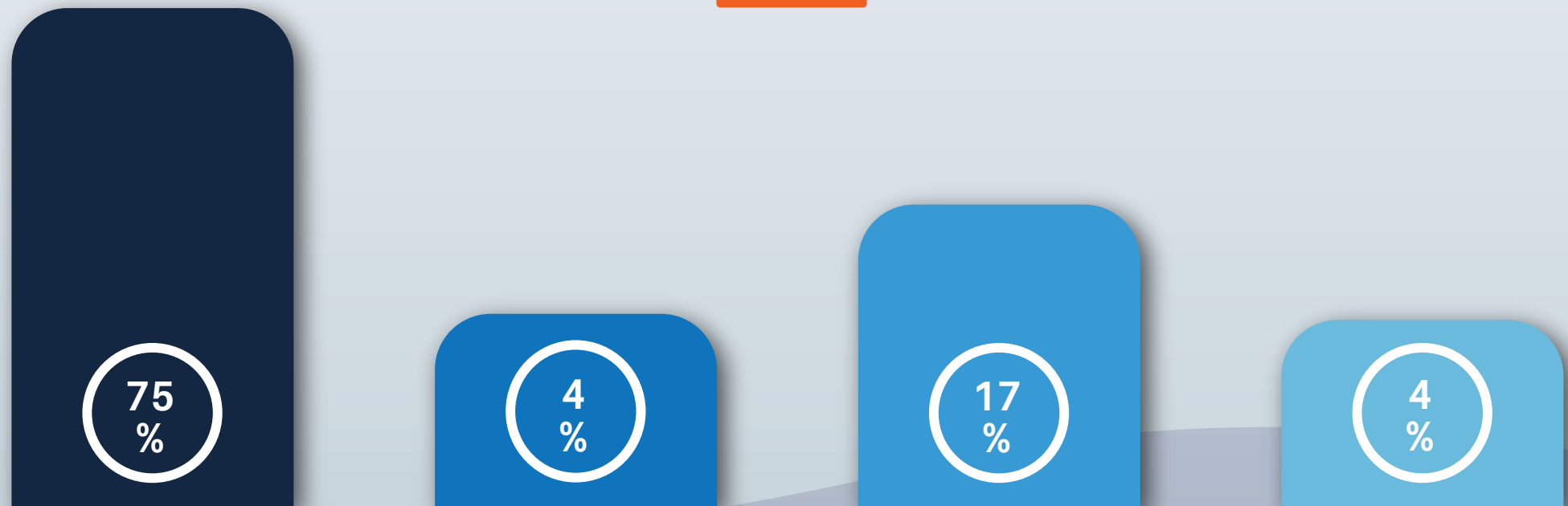
